THERAPEUTIC HORSEMANSHIP CONTINUED TO BE THE LARGEST PROGRAM OFFERED TO CLIENTS. DURING 2022, APPROXIMATELY 383 LESSONS WERE PROVIDED TO 30 INDIVIDUALS. HEALING REINS CONDUCTED THE "READING WITH ROCKY" LITERACY PROGRAM IN SCHOOLS DURING 2022.
